Ladies and Gentlemen,

- O Joint military exercises present US and multinational forces with realistic exercise threats that closely replicate operational challenges that military forces encounter around the world.
- 1 Two thousand five hundred soldiers from Hungary, the United States, Italy and Slovenia converged on Kecskemét airbase to take part in the military exercise named Hungarian Response.
- Lieutenant Colonel Caraccilo of the US Army climbed aboard a transport helicopter, aware of the delicate mission that lay ahead. The government of Derutia, a close US ally, was withering under an assault by guerrillas, and asked Washington for military assistance.
- 3 US forces had evacuated the US Embassy, and others were preparing to assault enemy positions. But first, Caraccilo and his troops needed to get US citizens out of harm's way. Seventeen American civilians students, tourists, and businesspeople were trapped in an abandoned school building near fierce fighting.
- It was the mission of Caraccilo's taskforce to secure the area around the building and extract the stranded people. The drama was part of a training exercise last week in south-central

Hungary, and Derutia is an imaginary country. Such drills have gained urgency since September

5 Caraccilo and his troops expect to face similar real-life challenges soon. They belong to the

Army's new Immediate Ready Force, which must be prepared to deploy within forty-eight hours to

trouble spots in Europe, Africa, and parts of the former Soviet Union.

6 Military officers say lessons learned in Kosovo motivated them to establish a new force.

When NATO went to war in 1999 to oust Yugoslav forces from Kosovo, the Army was criticized for

being too slow to deploy ground troops and attack helicopters to augment airstrikes against Serbia.

Soon thereafter, the Immediate Ready Force, which had been on the drawing board since 1998,

was implemented.

7 To meet the new challenges, the Army has said it needs to become faster, lighter, and

more mobile. Exercise Hungarian Response, which was conducted at the former Soviet MIG base,

gained special significance because it marked the first time the new Force deployed all its

components in the given time frame and operated in simulated combat.

The exercises ran from May the thirteenth to the twenty-second.

9 Prior to the exercise, the US had deployed 148 vehicles and 37 aircraft to Hungary from the

US bases in Aviano, Italy, and Ramstein, Germany.

10 On the first day of the exercise, the 2000 American troops joined about four hundred

Hungarian troops and about one hundred Italians. The Slovenian Forces were not deployed to the

exercise location, they provided air defence from their home bases. Major General Robert Wagner,

who was the overall commander of the drills, said the success of the joint exercise demonstrated

the value of America's NATO allies.
